April 21, Wednesday	Workshop for training on the “SECURE-REP” website; Release of CY 2009 ASC Appendix 1 Template and Forecast Model
May 3, Monday	<i>BPA releases revised CY 2009 ASC Appendix 1 Template and revised Forecast Model (if required)</i>
May 10, Monday	BPA assigns 2012-2013 Review Process Docket Numbers
June 1, Tuesday	Utilities file electronic Appendix 1 Filings to BPA’s Secure REP web site
June 8, Tuesday	Deadline to file petitions to intervene w / BPA. If intervenor intends to review Confidential Information, Consent to be Bound form must be included with intervention.
June 11, Friday	Utility must notify intervenors of any objections to Qualified Persons
June 11, Friday	Objections to petitions to intervene due to BPA
June 15, Tuesday	BPA grants or denies petitions to intervene
June 15, Tuesday	Utilities’ objections to Qualified Person due to BPA
June 16, Wednesday	Begin data request period for all parties <i>(Responding Utility has 10 calendar days to respond)</i>
June 21, Monday	Responses due to Utility’s objections to Intervenors’ Qualified Person
July 30, Friday	End data response period
Aug 24, Tuesday	Deadline for BPA and parties’ issue lists on Utilities’ filings
Aug 31, Tues	Clarification workshop on Generic Issues
Sept 3, Friday	Deadline for reply to issue lists from all parties on Utilities’ filings
Sept 13, Monday	Clarification workshop to discuss issue lists on Utilities’ filings
<b>Nov 19, Friday</b>	<b>BPA publishes Draft ASC Reports (coincides with release of BP-12 Initial Proposal)</b>
Dec 3, Friday	ASC Draft Report Clarification Workshop
<b>Dec 20 – Jan 2, 2011</b>	<b>Winter Break</b>
Jan 21, Friday	Deadline to request oral argument
Jan 28, Friday	BPA grants or denies requests for oral argument
Feb 15, Tuesday	Oral Argument (if granted)
Feb 25, Friday	Deadline for Utilities’ and parties’ comments on Draft ASC Reports
July 25, Monday	BPA Administrator issues Final ASC Reports
