Subject: Request for Public Scoping Comments and Open House Public Meetings Announcement for Programmatic Environmental Assessment Addressing Federal Support of the Phase 2
Implementation Plan: Testing the Feasibility of Reintroduced Salmon in the Upper Columbia River Basin

Dear Interested Party:

The Bureau of Reclamation (Reclamation), Bonneville Power Administration (BPA), and U.S. Army Corps of Engineers (USACE), collectively referred to as Co-Lead Agencies, are leading the preparation of a programmatic environmental assessment (EA) under the National Environmental Policy Act (NEPA) for federal support of the "Phase 2 Implementation Plan: Testing the Feasibility of Reintroduced Salmon in the Upper Columbia River Basin" (P2IP). The P2IP was developed by the Confederated Tribes of the Colville Reservation, Spokane Tribe of Indians, Coeur d'Alene Tribe, and Upper Columbia United Tribes to test the feasibility of salmon reintroduction upstream of Chief Joseph Dam into the historic salmon habitats in the United States. Interested parties are invited to participate in the P2IP NEPA process starting with the 30-day scoping period. The scoping period will be open from February 9, 2024, to March 11, 2024.

Reclamation, BPA, and USACE need to consider and respond to the P2IP proposal developed by Project Proponents with respect to Federal actions, in accordance with applicable laws, regulations, and authorities. The P2IP involves activities over an approximately 20-year period to test key biological assumptions through salmon research studies, develop interim hatchery and passage facilities, establish sources of donor and brood stocks for reintroduction, and evaluate effectiveness. Federal actions associated with the P2IP to be considered in the programmatic EA include:

- Funding P2IP activities throughout the project area, including research studies, interim fish passage, and fish rearing.
- Reviewing, approving, and issuing permits for actions including but not limited to data collection, installation of equipment, or facility construction on federally managed lands and facilities.
- Providing eggs and juvenile and adult salmon from existing hatcheries for research studies.

The Co-Lead Agencies are seeking scoping comments on this project. We are contacting stakeholders, potentially interested persons, groups, tribes, tribal citizens, and agencies to inform them of the project and gather pertinent feedback. We request comments to help identify potential issues to consider in this environmental compliance effort. Your comments will help us refine the proposal, identify interested and affected persons who should learn more about this NEPA process, and consider possible alternatives to the Proposed Action.

This public scoping process will also meet our public involvement obligations under Section 106 of the National Historic Preservation Act. We invite your comments on the potential for this project to result in adverse effects to historic properties, if any.

The Co-Lead Agencies will host two in-person open house format meetings:

- In-Person Meeting: February 27, 2024, 5-7pm Pacific Time (PT) in Grand Coulee, WA at Colville Tribal Museum
- In-Person Meeting: February 28, 2024, 6-8pm (PT) in Airway Heights, WA at Kalispell Northern Quest Casino

In addition to the in-person public meetings, a virtual public meeting website will be accessible 24 hours a day to provide project information and allow visitors to submit comments.
