Nonresidential Lighting Calculator LC6.0 available for download

In preparation for the new rate period starting Oct. 1, 2023, BPA has added a new version of the Nonresidential Lighting Calculator, LC6.0, to the Commercial accordion in the online <u>Document Library</u>. This calculator becomes effective Oct. 1, but is available for download now in order to allow utility customers the opportunity to become familiar with the changes/updates and to customize as needed.

Some key differences between LC6.0 and LC5.1 include:

- Distinct incentives for Type A and Type B or C LED tubes.
- Incandescent bulbs are no longer an eligible baseline.
- Additional LED wattage options in select dropdown fields.
- Increased incentives for Networked Lightning Control measures.
- Updated busbar factor and B/C ration calculations to align with the 2021 Power Plan.

Please note the Nonresidential Lighting Calculator LC5.1 will expire March 31, 2024.
