Intended to facilitate the submission of complete and appropriate cost documentation to support energy efficiency custom projects, the Custom Project Cost Documentation Guide defines allowable costs (e.g., implementation costs, impacts to O&M costs, and changes in non-energy impact costs) under different custom project types and specifies the supporting documentation required...
