Performance Tested Comfort Systems: HSPF2/SEER2-rated heat pumps entering the market early

As previously announced in August and September, DOE's national standard for heat pumps will change with units manufactured beginning Jan. 1, 2023. These units will be rated using a more rigorous test methodology than the prior Heating Seasonal Performance Factor, or HSPF, or Seasonal Energy Efficiency Ratio, or SEER, methodology and provided a new HSPF2/SEER2 rating...More
