Thank you for your letter of April 27, 2005, requesting information under the Freedom of Information Act. Specifically you asked for copies of contracts in effect during the past ten (10) years between the Bonneville Power Administration and Davis Bacon; Maslonka & Associates; and/or Info Source. Your request has been logged as FOIA #05-040.

During our subsequent telephone conversations, you narrowed the scope of your request to include only those portions of the contracts that reference hourly rates, cost information for fringe benefits, and wage rate determination and classification per and federal guidelines.

In your original letter, you agreed to pay fees of up to \$10 to process your request. Again, per our telephone conversations, you have agreed to pay reasonable fees to process your request. Should fee estimates to process your request exceed \$100, we will contact you before proceeding.
