**Description of Request:** Pursuant to the Freedom Of Information Act, I am requesting a complete listing of Name, Address1, Address 2, City, State, and Zip Code of all property owners that received the initial letter from BPA outlining the plans for routing new 500KVA power lines from Castle Rock Washington to Gresham Oregon. Information should be listed in Excel (or a text file) with a single line (row or record) for each recipient of the letter.

**Preferred format:** Excel, single row per property owner's information

**I request a waiver or reduction of fees because my request concerns "the operations or activities of the government" as explained below:**

*The information being requested concerns the operation and activities of the Bonneville Power Administration because BPA may operate power lines on these properties. They are also requesting Permission to enter Property (PEP) forms be signed by the property owners where BPA can enter the property and perform such "activities" as surveying.*
