### **Savings for the Green Motors Program are available in the PTR -**

Utilities can now access a full report of savings achieved through BPA's Green Motors program in the PTR system. When logged into the PTR, this report can be found by selecting "Your Account" then choosing "BPA Green Motors Reports" under the Orders/Reports heading. This report will show a different total savings when compared with the original Green Motors Initiative (GMI). GMI reports originally reflected only the deemed site savings, not busbar energy savings. The PTR has always recorded busbar savings, not site savings; this discrepancy was corrected in 2010. Additionally the busbar multiplier changed from 1.07625 to 1.09056 in 2011, which increased the busbar savings reported for each motor in 2011.
