Updates to the RTF Residential Weatherization Specifications -

On August 30, 2011 the Regional Technical Forum (RTF) approved an update to the Residential Weatherization Specifications, as part of the RTF's three year revision cycle for specifications.

Over the next six months, BPA will work with public utilities to determine whether to implement some or all of the updated weatherization specifications. BPA anticipates that a formal change notice will be provided in the Implementation Manual on April 1, 2012 and that new specifications for Residential Weatherization will take effect October 1, 2012.

NEEA'S Commercial Building Stock Assessment -

In the coming months, NEEA with the support of BPA, the RTF, and other regional utilities and stakeholders will begin planning the Commercial Building Stock Assessment (CBSA). The CBSA is a regional study of commercial buildings assessing their size and type in relation to features such as energy-use, equipment, lighting and controls and size.

Measure Expiration Dates in the PTR Extended for Reporting Only -

Expiration dates on some measures have been extended in the Planning, Tracking and Recording (PTR) system solely to allow for year end close-out reporting.



Measure expiration dates currently listed in the PTR System refer only to the changeover from the PTR System to EE Central, unless otherwise communicated in the change notification section of the Energy Efficiency Implementation Manual. Because the PTR programmatically verifies measure eligibility, measure expiration dates have been extended to 11/30/11 in the PTR to ensure measures are available for utilities to generate Conservation Rate Credit (CRC) close-out reports for FY 2011.
