SUBJECT: Errata to Temporary Instruction 09-2, American Reinvestment and Recovery Act (ARRA).

Effective Date: October 5, 2009

Effective Until: Revised or Cancelled

Interpretations of statutory obligations and the details of implementing the American Reinvestment and Recovery Act (ARRA) continue to evolve. This Temporary Instruction or Revisions thereto, will be the source for purchase policy and related procedures for ARRA at BPA. Some provisions may be developed at the operations level in Supply Chain Services.

The following corrections/revisions are made to Temporary Instruction 09-2, which is fully republished as Temporary Instruction 09-2 Revision 1. The location of each change noted below is indicated by a dark vertical line on the left side of the page.

Page 7	Subpart 4.1.3.1	A new paragraph (a) is added to include modified reporting requirements for awards made with funds attributed to ARRA through use of increased borrowing authority. The remaining paragraphs are renumbered.
Page 8	Subpart 4.1.3.3	Paragraphs (c) and (d) have been revised to include the reporting requirement for awards attributed to the agency's increased borrowing authority under the Recovery Act increased.
	Subpart 4.1.3.4	A new paragraph (a) is added with the usage prescription for clause 4-48.
	Subpart 4.50	Clause 4-48 is added to the list of clauses.
Page 9/10	Clause 4-48	Add new Clause 4-48 American Recovery and Reinvestment Act-Reporting Requirements-Projects Using Increased Borrowing Authority Attributed to ARRA.
Page 14	Instructions to COs	Correct the spelling in second paragraph to "...BUY AMERICAN ACT..."
	Subpart 9.2.5.1	Correct the term to "project".

Page 15	Subpart 9.2.5.4(a)	Correct the BPI reference to "9.2.5.3".
Page 16	Subpart 9.2.5.5(a)(1) Subpart 9.2.5.5(b)(2) Subpart 9.2.5.5(c)(1)	Delete the last sentence "See BPI at 9.1.1(a)(3)." Correct the BPI reference to "See BPI 9.2.5.5." Correct the two BPI references to "9.4".
Page 17	Subpart 9.2.5.5 (c)(3) Subpart 9.2.5.7	Add new content to address Canada's status with respect to Free Trade Agreements. A new paragraph (a) is added. COs must inform offerors to submit information in contract clauses 9-46 or 9-48, whichever is applicable and included in the draft contract, as provided to offerors during the acquisition phase. The remaining paragraphs are renumbered.
Page 18	Subpart 9.2.5.8(b)	Correct the clause number to "9-46".
Page 19/20	Subpart 9.2.5.10	All clause usage prescriptions have been revised to clarify the conditions for use of the basic clauses or alternates. An Alternate III to clause 9-49 has been added.
Page 26	Clause 9-48	Definitions section: delete "Canada" from the list of countries in paragraphs (1) and (2) in the definition of " <i>Recovery Act designated country</i> ".
Page 31	Clause 9-49	Add Alternate III (Oct.09) notes.
Page 32	Subpart 12.8.8.1(b)	Eliminate the reference to paragraph (e) in last sentence.
Page 34	Clause 14-49	Correct the paragraph numbering in subparagraph (f).
Page 35	Item 8 Subpart 25.1.1(b)	Section 8 is added to the Temporary Instruction for Part 25 INTERGOVERNMENTAL CONTRACTS. A new subparagraph (10) is added with clause usage prescriptions for ARRA awards to State and local governments and Tribes.
