On or about October 16, 2000, Avista Corporation, Bonneville Power Administration, Idaho Power Company, Montana Power Company, Nevada Power Company, PacifiCorp, Portland General Electric Company, Puget Sound Energy, Inc., and Sierra Pacific Power Company ("Filing Utilities") filed with the Federal Energy Regulatory Commission ("Commission") an "Alternative Filing Pursuant to Order No. 2000." WHEREFORE, MAC respectfully requests that its Petition to Intervene be granted and that the aforementioned persons be added to the official service list.


