
Re: **Docket UE 200 – Renewable Adjustment Clause**  
Attestation for Seven Mile Hill - Updated

On December 31, 2008, PacifiCorp d.b.a Pacific Power filed an Attestation signed by Rob Lasich, President of PacifiCorp Energy, for the Seven Mile Hill wind resource. As required by the Commission's approval of Advice No. 08-021/UE 200, the Attestation was filed by 12:00 p.m. (Noon) on December 31, 2008. As indicated in the filing, less than 100 percent of the project turbines at Seven Mile Hill were producing power and connected to the transmission facilities as of 10 a.m. on December 31, 2008. However, by 12:00 a.m. (midnight) on December 31, 2008, 100 percent of the project turbines were producing power and connected to the transmission facilities. Pacific Power hereby submits an updated Attestation signed by Rob Lasich for Seven Mile Hill. The signed original is being sent via overnight delivery.

Because the Seven Mile Hill resource was found prudent by the Commission in Order Nos. 08-548 and 08-554, concurrent with this filing the Company is making a separate tariff filing in Advice 09-001 to include Seven Mile Hill in the rates in Schedule 202, Renewable Adjustment Clause. The Company is requesting an effective date of January 21, 2009.


