**GENERAL INFORMATION:** The incumbent will report to Jeff Neyman.

The Data Systems Craftsman (DSC) independently performs preventive, corrective, and emergency maintenance on the full-range of data system equipment located in the Control Center. Inherent in the nature of information, digital, and data system technology work is the evolution of data systems and information technology equipment, systems, and software applications. Data System Craftsman are required to keep abreast of the latest technological developments in hardware (e.g., server, router, switch, IP, security, communication, etc.) as well as software applications (e.g., operating systems, databases administration, network, user interface, security, communications, etc.) while maintaining competence in older hardware and software applications still in use.

## MAJOR DUTIES:

Data System Craftsman report to Manager, Control Center Hardware Maintenance organization or the Control Center Manager. DSC performs duties independently and in compliance with government regulations, BPA policies and work guides, safety rules, and the BPA-CPTC collective bargaining agreement.

The Data Systems Craftsman performs preventive, corrective, emergency maintenance, assembly and installation of various types of data system equipment. The incumbent performs all duties without more than normal supervision and in compliance with government regulations, BPA safety rules, and the BPA-CPTC Collective Agreement.

- Performs initial energization tests of new installations and obtains data to be used by other personnel.
- Uses technical documentation as required, for maintenance and troubleshooting of equipment.
- Completes associated documentation required of the above listed tasks.

## SPECIAL SKILLS AND ABILITIES:

Specialized experience for this position is defined as: 1) Ability to perform the work of a data systems craftsman without more than normal supervision 2) Knowledge of Data System equipment, assembly, adjustment, repair, and computer hardware installation practices. 3) Theory of electronics. 4) Knowledge of real-time control and data acquisition systems. 5) Ability to use hand and power tools - electronics. 6) Ability to use test equipment (electronic data systems). 7) Troubleshooting (electronic equipment). 8) Ingenuity (ability to suggest and apply new methods). 9) Knowledge of network communications and network And 10) Knowledge of network security applications and issues.
