To: People interested in the Allston to Astoria Rebuild Project

Bonneville Power Administration (BPA) is proposing to rebuild two existing transmission lines in your area. This letter explains what is being proposed, outlines our anticipated environmental review process and schedule, and requests your comments.

Proposal: BPA proposes to rebuild its existing approximately 22-mile-long Allston to Driscoll No. 2 and the approximately 21-mile-long Driscoll to Astoria No. 1, 115-kilovolt transmission lines (see enclosed project map). Together, the proposed rebuilding of the two lines is referred to as the Allston to Astoria Rebuild Project. The lines are located in Clatsop and Columbia counties and cross sections of lands owned by the State of Oregon. The Allston-Driscoll No. 2 and Driscoll-Astoria No. 1 transmission lines, have been in service for around 70 years and are rapidly approaching the end of their service lives. The lines are experiencing performance issues due to age, inadequate design, and overall condition which results in continued loss of service. The lines need to be rebuilt to ensure reliable electric service and the safety of the public and transmission workers.

Along both lines, the work would include replacing the existing conductors, H-frame wood pole structures, wood monopoles, selected steel structures, and all hardware. The transmission line rights-of-way would be cleared of certain vegetation and danger trees would be removed. In addition, access roads would be improved and reconstructed; and a small amount of new roads would be constructed.

The proposed project would also involve work within BPA's Allston and Clatskanie Public Utility's Delena substations.

Environmental Review and Surveys:

To understand the potential environmental impacts of this proposal, BPA may prepare an environmental assessment (EA). If BPA determines that an EA should be prepared, the EA will describe anticipated impacts to natural and human resources and include mitigation measures that would help avoid or minimize impacts. We are asking for your comments to help determine the issues that should be addressed in the environmental review. During this process, BPA will work with Federal, state, and local agencies, Tribes, potentially affected landowners, and other interest groups. The proposed schedule for the environmental review process is as follows:
