Your review and comments are requested on the draft environmental impact statement (EIS) for the Chief Joseph Hatchery Program in north-central Washington. The draft EIS describes the proposed hatchery facilities and the fish production program, and provides the environmental effects expected from facility construction and program operations. Public comments on the draft EIS will help project partners refine the environmental analysis and decide whether to implement the program.

The Bonneville Power Administration (BPA) produced the draft EIS and would fund the construction and operation of the facilities, if approved. The Confederated Tribes of the Colville Reservation proposed this project and the U.S. Army Corps of Engineers, Washington Department of Fish and Wildlife, Washington Parks and Recreation Commission, Oroville-Tonasket Irrigation District and others assisted with project design and siting.

Project background

The proposed action is to build a hatchery just below Chief Joseph Dam on the Columbia River for incubation, rearing and release of summer/fall and spring Chinook salmon. Juvenile fish acclimation and release ponds would be located strategically throughout the Okanogan River valley, consisting of a combination of modified, existing irrigation ponds as well as newlyconstructed ponds. The project would help mitigate for Chinook salmon in the Okanogan River basin affected by the dams of the Federal Columbia River Power System. The project also aims to increase anadromous fish populations to enhance the potential for tribal ceremonial and subsistence harvests and a recreational fishery for the general public.

BPA and others involved in this project will be available to discuss the project and the draft EIS, and receive any written comments during either of the two open house meetings below.

All comments are encouraged. Of particular interest are specific suggestions related to the quality of the environmental analysis in the draft EIS, or any recommendations for making the project more environmentally friendly while still fulfilling its intended purposes. A final EIS is scheduled for completion in the fall of 2007. BPA expects to issue a record of decision in the fall of 2007 on whether to implement the project.
