To: Parties interested in the Hills Creek-Lookout Point Transmission Line Rebuild Project

The Bonneville Power Administration (BPA) has prepared a draft environmental assessment (EA) for the proposed Hills Creek-Lookout Point Transmission Line Rebuild Project. The draft EA describes the project and why it is needed, discusses the environmental impacts the project would create, and lists the mitigation measures that would lessen or eliminate those impacts. This letter requests your comments on the EA and outlines the next steps for the project.

BPA proposes to rebuild the 26-mile, 115-kilovolt Hills Creek-Lookout Point wood-pole transmission line between the City of Oakridge and Lowell, Oregon. The line was originally built in 1953 and is showing normal deterioration due to age. The rebuild would replace all wood-pole structures, replace conductors and ground wires, and improve access roads.

BPA also proposes to realign two sections of the transmission line recently damaged by rock fall and landslides. These sections of line are within Willamette National Forest. The U.S. Forest Service is a cooperating agency in the development of the EA and is considering whether to issue a special use permit to allow BPA to realign the sections of line.

The Forest Service Responsible Official, District Ranger Duane Bishop, has identified BPA as the designee to receive comments on this project. On March 27, 2013, a final rule revising 36 CFR Part 218 was published in the Federal Register Volume 78, No. 59. The new rule replaces the previous USFS appeal rules defined in 36 CFR 215, and expands the use of the pre-decisional objection process. The new rule provides the public an opportunity to comment and express concerns on projects before decisions are made, rather than after. This project is subject to USFS specific pre-decisional objection regulations. Only those who submit timely and specific comments regarding the proposed project or activity during a formal public comment period, such as this one, established by the Responsible Official, are eligible to file an objection. For objection eligibility, each individual or representative from each entity submitting timely and specific written comments regarding the proposed project or activity comments must either sign the comments or verify their identity upon request. All comments will be posted in their entirety on the project website.
