## To: People Interested in the East Fork Irrigation District Modernization Project

The Natural Resources Conservation Service (NRCS) has finalized the Watershed Plan Environmental Assessment (Plan-EA) for the East Fork Irrigation District Modernization Project. Based on the final Plan-EA, BPA is proposing to adopt the Plan-EA and is issuing a finding of no significant impact (FONSI) and made a decision to proceed with the project. This letter describes BPA's decision, the construction schedule and how to obtain additional information.

**Back ground:** BPA would fund a portion of the project to improve the Eastside Lateral Pipeline in Hood River, Oregon, part of the East Fork Irrigation District's distribution infrastructure. The project would convert the open irrigation canals to closed, pressurized irrigation infrastructure to improve the efficiency of the irrigation district.

NRCS, in cooperation with BPA, prepared a Plan-EA to help determine if the project would cause significant impacts that would warrant preparing an environmental impact statement. NRCS, in cooperation with BPA, released the draft Plan-EA for public review and comment in January 2020 and received 27 comments. The final Plan-EA responses to those comments and the revised Plan-EA were released with NRCS' FONSI in July 2020. Based on the Plan-EA analysis and mitigation measures to help lessen impacts, BPA has found that the project would not cause any significant impacts and, therefore, an environmental impact statement will not be prepared.

**BPA Decision**: BPA decided to fund improvements to the Eastside Lateral Pipeline, which is a portion of the East Fork Irrigation District Modernization Project. Project construction is expected to begin in Fall 2020 and continue through Fall 2024, with breaks in construction during seasonal restrictions.
