#### To: Parties Interested in the Grand Coulee-Creston Transmission Line Rebuild

Bonneville Power Administration (BPA) has prepared a draft environmental assessment (EA) for our proposed Grand Coulee-Creston Transmission Line Rebuild. This letter requests your comments on the EA, invites you to public meetings, and outlines the project's next steps.

As you may know, BPA is proposing to rebuild nearly 28 miles of the Grand Coulee-Creston No. 1 115-kilovolt (kV) transmission line between the cities of Coulee Dam in Grant County and Creston in Lincoln County, Washington. The proposed project would include replacing all woodpole structures (including poles, cross arms, cross braces, guys, anchors and insulator assemblies) and conductor (including groundwire), improving existing access roads, developing temporary access roads, and removing tall growing vegetation in the right-of-way. The rebuilt line will continue to operate at 115-kV. The intention is that the rebuilt line will maintain the same structure locations and similar pole heights as the existing line. The existing line was built in 1941 and is in need of replacement due to age and deterioration. Rebuilding the line would help maintain reliable electrical service and avoid risks to the safety of the public and maintenance crews.

#### **Draft EA**

The draft EA further describes the project and why it is needed, discusses the environmental impacts the project would create, and lists the mitigation measures that would lessen or eliminate those impacts.
