### **To: Parties interested in the Salem-Albany Transmission Line Rebuild**

Bonneville Power Administration (BPA) has prepared a draft environmental assessment (EA) for the proposed Salem-Albany Transmission Line Rebuild Project. This letter requests your comments on the EA, invites you to public meetings, and outlines the next steps for the project.

BPA is proposing to rebuild the 24-mile Salem-Albany No. 1 and the 28-mile Salem-Albany No. 2 wood-pole transmission lines. The lines run from Salem to Albany, Oregon, through Polk, Benton, Marion, and Linn counties. The proposed project would include replacing all components of the two transmission lines, including the wood poles and conductors (existing fiber on both lines would remain). Associated activities would include improving, acquiring, and building access roads and removing trees where needed. The proposed project is needed due to the age and deterioration of the two lines.

Since BPA conducted public scoping for the proposed project in January 2013, there have been some changes to the proposed design. Most notably, the design changed to address safety issues from the proximity of the line to the edge of the right-of-way on Salem-Albany No. 1. The proposed solution would be to move portions of the transmission line to the center of the right-of-way, move some structures forward or back, and replace about nine miles of H-frame wood poles with steel monopoles. Chapter 2 of the draft EA explains this and other project details.

### **Draft EA**

The draft EA further describes the project and why it is needed, discusses the environmental impacts the project would create, and lists the mitigation measures that would lessen or eliminate those impacts.
