To: Parties Interested in the Steigerwald Floodplain Restoration Project

The Bonneville Power Administration (BPA) will be preparing an environmental assessment (EA) to analyze the effects of the proposed Steigerwald Floodplain Restoration Project. This letter briefly explains what is being proposed, outlines our environmental review process and schedule, invites you to a public meeting, and requests your comments on the proposal.

Proposal - BPA is proposing to fund the Lower Columbia Estuary Partnership's proposal to restore floodplain connectivity to the Columbia River within the Steigerwald Lake National Wildlife Refuge (Refuge) in Clark County, WA (see enclosed map). The Refuge is managed by the U.S. Fish and Wildlife Service. The project would help improve water quality and habitat to benefit steelhead and cutthroat trout, Chinook, coho, and chum salmon, and Pacific and western brook lamprey. The project would involve reconnecting Gibbons Creek to the Columbia River by breaching a U.S. Army Corps of Engineers' levee; removing a diversion structure, fish ladder, elevated channel, and water control structure; replacing a state highway bridge; constructing a setback levee; enhancing approximately two miles of wetland channels; and re-establishing the site's riparian forest.

The proposal has been recommended for funding by the Northwest Power and Conservation Council and would help BPA meet commitments under the Northwest Power Act to mitigate for impacts of federal dams on the Columbia River and its tributaries and meet obligations under the Endangered Species Act.

Environmental Review - BPA will prepare an EA under the National Environmental Policy Act to analyze the potential impacts of the project and identify ways to reduce those impacts. The EA will describe anticipated impacts to natural and human resources and include mitigation measures that would help avoid or minimize these potential impacts. We are asking for your comments to help determine the issues that should be addressed in the EA. During this process, BPA will work with federal, state and local agencies, tribes, landowners, and interest groups. The U.S. Fish and Wildlife Service and the U.S. Army Corps of Engineers will be participating as cooperating agencies on the EA. The proposed schedule for the EA process is as follows:
