BPA just completed an impact evaluation of Residential Air-Source Heat Pumps and Variable Speed Heat Pumps. The Comfort Ready Home Process Evaluation is in the early stages and the Non-Industrial Custom and Energy Smart Reserved Power (ESRP) Impact Evaluation is currently in the reporting phase.
