BPA Energy Efficiency Tracking System Blackout Period

BPA Energy Efficiency Tracking System (BEETS) will shut down from Thursday, Sept. 25 through Friday, Oct. 17, 2025, to make necessary system updates for the upcoming rate period. BEETS may go live earlier if the system updates are completed sooner than expected.

During this time:

- All activity in the system will pause, including invoicing current applications, completing application tasks, and submitting new applications through bulk or manual upload.
- Current rate period dashboard information will not be available.
- All Activity Report and Invoice Detail Report information will remain available.

As BPA implements updates, energy efficiency representatives (EERs) are available to answer questions.
