\*BPA Tier 2 Incentive qualifiers may also be earned by satisfactorily completing Earth Advantage Multifamily Platinum certification plus meeting minimum energy efficiency thresholds, pre-renewable, of at least 25% over permitted code or building Site EUI of 20 (kBtu per gross square foot per year).
