# Setting Expectations



### Setting Expectations: Survey Highlights

#### Responses from 65 participants

- Variety of participants:
  - ✓ 51% from **Utilities**
  - ✓ 29% from CAPs
  - ✓ Remaining 20% from government, non-profits, and implementers
- 86% have a low-income program
- 52% are new to the BPA low-income workgroup
- 53% prefer quarterly, hybrid meetings; 47% prefer 2 3 times a year

### Setting Expectations: Intended Format

- BPA program updates as needed
- Open discussion to collaborate on issues and highlight achievements
- Speaker presentations
- Technical trainings
- Discussions on program design
- Cross-agency collaboration
- Breakout sessions and small-group discussions when possible



#### Setting Expectations: Intended Format

- Host at least three workgroups a year
- Host in-person with a virtual option where possible, coinciding with existing in-person meetings to decrease travel
- Host every other meeting in Portland and remaining meetings around the region

Efforts will depend on available staff resources and meeting spaces with hybrid meeting options.

- Small, balanced committee made up of utilities, CAPs, and other interested parties
- Participation is voluntary
- Commitment is for one year and can be renewed
- Additional 4 6 one-hour meetings per year
- Tasks include but aren't limited to:
  - ✓ Providing input on agenda items
  - ✓ Prioritizing discussions
  - √ Identifying speakers
  - ✓ And more...

- Six open positions: Three Utility & Three Non-Utility
- Soliciting volunteers to participate now
- BPA will follow-up with the eligible survey participants who expressed interest
- Deadline to fill open positions is May 31st



# BPA Program Updates



### Quick Pause: BPA Caveat

BPA establishes minimum requirements for its energy efficiency measures. Customer utilities, states, and tribes implementing BPA funding have final say on what measures they offer and at what incentive level. They frequently include additional requirements to satisfy internal policies.



#### New Deemed Measures Effective April 1, 2024

#### **Low-Income Ductless Heat Pump in Multifamily**

- Available for low and mid/high-rise multifamily buildings
- Payment cap is dollar-for-dollar up to \$6,000 per installation
- Follows existing technical, installation, and documentation requirements of current ductless heat pump measure

#### **New Low-Income Custom Residential Project Rate**

- For retrofit residential applications only
- Custom projects payments of \$5.00/kWh or up to 70% of project cost, whichever is lower
- Excellent option for exploring new low-income projects

#### Cliff's Notes: Low-Income Process Evaluation

**BPA's Low-Income** and **Evaluation teams** worked with the independent evaluators to identify opportunities to expand low-income activity through EEI-funded utility programs.

- Final report and corresponding BPA response memo posted to be soon
- Report will include information on:
  - BPA program and uptake analysis
  - Utility and CAP interviews
  - Best practices and national literature review
  - Demographic analysis
  - Analysis on savings potential



#### Cliff's Notes: Low-Income Process Evaluation

## Seven primary findings and recommendations from the Evaluator, including but not limited to:

- Discussing how payment cost caps impact program uptake
- Considering if a whole-home measure option could be made available
- Updating elements of the program to improve reporting
- Improve how utility and grant funding sources are designed so they don't conflict with each other
- Consider updating program elements to expand outreach
- Improve regional collaboration
- Suggested additional measure development



#### Cliff's Notes: Low-Income Process Evaluation

Goal: Post both the final evaluation report and BPA response memo to the BPA Energy Efficiency's Evaluation webpage this month.

Next steps for these findings and recommendations:

- Prioritize efforts internally through a strategy process
- Discuss priority topics with the Low-Income Steering Committee and ultimately the larger low-income workgroup
- Determine how to move practical solutions to some of these larger issues forward
