






□ 8.7.6 Variable Frequency Drive for Pumps



New Measures Effective April 1

Ductless Heat Pumps: Residential Retrofits in Low and Mid/High-Rise Multifamily Buildings for units with existing zonal heat

- □ 11.5.1 Ductless and Ducted Mini-Split Heat Pumps
 - Converted from a custom project to a streamlined UES measure
 - Incentive: \$800 per installation
 - Savings per RTF: 1,300 kWh per installation
- □ 11.9 Low-Income Energy Efficiency Measures: Ductless or Ducted Mini-Split Heat Pump(s) or Ductless Heat Pump (DHP) Conversion (Zonal Electric Heat Pre-Condition)
 - Converted from a custom project to a streamlined UES measure
 - Incentive: \$6,000 per installation
 - Savings per RTF: 1,300 kWh per installation
 - Added to the low-income table

Measure Extension

☐ 11.7.3 Single-Family New Construction Performance Path

BPA extended the program for Single-Family New Construction Performance Path.
 Originally planned to sunset October 1, 2024, it has been extended to September 30, 2026, when it will be reassessed.

Requirement Corrections

☐ 11.5.1 Ductless and Ducted Mini-Split Heat Pumps

 All components of the heat pump must be replaced with the upgrade; must be Air-conditioning, Heating, and Refrigeration Institute (AHRI)-tested and Certified. Including this language to meet the measure requirements.

☐ 11.5.4 Variable-Speed Air-Source Heat Pump Upgrade

All components of the heat pump must be replaced with the upgrade; must be AHRI-tested and Certified.
 Including this language to meet the measure requirements.

☐ 11.5.8 Prescriptive Duct Sealing (BPA-Qualified)

o Clarified the "End-user identifying information including unique site ID and address" must be kept in the

customer file.

☐ 11.8.2 Prime Window and Patio Door Replacement

 Corrected a typo in the payment table to clarify that windows are available in Multifamily Mid/High-Rise homes.

□ 11.8.7 Door Sweep

- Clarified that this measure is only available in electrically-heated homes to align with RTF requirements.
- Measure list updated to clarify payment is per door sweep.

- Savings for low-income Advanced Smart Thermostats trued up/corrected to match their non-low income measure equivalent.
- Savings for low-income Tier 3 Heat Pump Water Heaters in HZ1 & HZ2 trued up/corrected to match their non-low income measure equivalent.

Requirement Correction

Definition Update

Single-family: Updated to avoid confusion, removed reference to privately owned.

"Fewer than five dwelling units within the same structure, including duplexes, triplexes, accessory dwelling units, and modular homes. Homes, such as townhomes, that are single-family dwelling units which are part of, and/or adjacent to other similarly owned single-family dwelling units that are connected and/or by separated from one another by a common-party wall having no doors, windows, or other provisions for human passage or visibility; but do not vertically overlap (must be side-by-side and not stacked vertically) may be considered single-family regardless of the number of units connected side by side. Accessory dwelling units with separate plumbing systems or separate HVAC systems qualify for applicable measures even if they are on the same electrical meter.

Definition Corrections

Updated terms "ROC" and "SEM" with additional information.

ROC: Refrigerator Operator Coaching: An Industrial Strategic Energy Management feature that provides classroom and webinar training and on-site technical support. ROC is designed to help industrial sites with ammonia refrigeration systems generate electrical energy savings, while getting the most out of their systems. The energy savings are calculated by site-specific energy models, following the measurement and verification requirements addressed in the BPA Commercial & Industrial Strategic Energy Management Measurement and Verification Reference Guide.

SEM: Strategic Energy Management: As defined by Consortium for Energy Efficiency's Minimum SEM Elements, a holistic approach to managing energy use to continuously improve energy performance by achieving persistent energy and cost savings over the long term. *SEM may include organizational training, technical support for operations and maintenance improvements, energy monitoring and reporting tools.*
