Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B1.3 Routine maintenance

<u>Description of the Proposed Action</u>: BPA proposes to replace deteriorating/damaged fiber between 18/3-20/1 on the Ellensburg-Moxee #1 transmission line. About 1 mile of fiber optic cable would be removed and new cable strung on the existing wood-pole transmission line structures. A trailer mounted single drum puller and tensioner will be used to pull in the fiber. Bucket trucks will be used to mount the fiber to each structure.

See table below for structure names and locations on the transmission lines.

Replacement would be in-kind and would utilize the existing structures to minimize ground disturbance. Access road maintenance would be limited to blading, grading, and rocking of access road segments that have become impassable. All road maintenance would take place in the existing road prism. The entire project area is located within DNR land.

The proposed action would allow safe and timely access to the transmission line, which would help reduce outage times and maintain reliable power in the region. All work would be in accordance with the National Electrical Safety Code and BPA standards.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.
