<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021):</u> B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

Description of the Proposed Action: Bonneville Power Administration (BPA) is proposing to fund the Kalispel Tribe of Indians (Kalispel Tribe) for the purchase of the Greyback Mountain property, a 240-acre parcel of land located roughly 7 miles south-southwest of the town of Usk in Pend Oreille County, Washington. BPA would hold a conservation easement to permanently protect, mitigate, and enhance fish and wildlife and their habitat. A portion of the funding for the acquisition would be provided by the Kalispel Tribe using proceeds from the Sand Creek parcel sale under the terms of the letter of agreement with BPA for obtaining replacement mitigation habitat for the disposed property, with the remainder provided by BPA. This CX has been updated to reflect BPA's retention of a conservation easement on the property.

The property consists of extensive upland forest and grassland which provides nesting habitat for bald eagle (*Haliaeetus leucocephalus*). The Kalispel Tribe would develop a land management plan to guide the protection and enhancement of habitat and other resources on the property. The land management plan would be drafted within 18 months of closing. The management plan would be reviewed by BPA for consistency with the conservation easement and the purpose of the acquisition. If BPA proposes to fund any additional activities on the property, further environmental review may be conducted.

Findings: In accordance with Section 1021.102 of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, Jul. 9, 1996; 61 FR 64608, Dec. 6, 1996; 76 FR 63764, Nov. 14, 2011; 89 FR 34074, April 30, 2024; 90 FR 29676, July 3, 2025 [Interim Final Rule]) and *DOE National Environmental Policy Act (NEPA), Implementing Procedures* (dated June 30, 2025), BPA has determined the following:

- 1) The proposed action fits within a class of actions listed in Appendix B of 10 CFR 1021;
- 2) The proposal has not been segmented to meet the definition of a categorical exclusion; and
- 3) There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal (see attached Environmental Evaluation).

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review. ¹

Proposed Action: Greyback Mountain Land Acquisition

Project Site Description

The Greyback Mountain is a 240-acre property located in central Pend Oreille County, Washington roughly 7 miles south-southwest of the town of Usk. The property consists primarily of upland forest with sparse grassland clearings throughout. The property was historically used for timber harvest but has not been actively logged in more than a decade. The forests on the property provide extensive nesting and hunting habitat for bald eagle, as well as habitat for a number of local terrestrial species like white-tailed deer (*Odocoileus virginianus*) and grey wolf (*Canis lupus*).
