<u>Categorical Exclusion Applied (from 10 C.F.R. Part 1021):</u> B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

<u>Description of the Proposed Action:</u> Bonneville Power Administration (BPA) proposes to fund the Kootenai Tribe of Idaho (KTOI) to purchase the Elmira property, an approximately 260-acre parcel of land located roughly 15 miles northeast of Sandpoint, Idaho in Bonner County. BPA would hold a conservation easement to permanently protect, mitigate, and enhance fish and wildlife and their habitat. This updated CX is being issued with revised property location information.

Funding the purchase of the property would support conservation of ESA-listed species considered in the 2020 Endangered Species Act (ESA) consultation with the U.S. Fish and Wildlife Service (USFWS) on the operations and maintenance of the Columbia River System, while also supporting ongoing efforts to mitigate for the effects of the Federal Columbia River Power System on fish and wildlife in the mainstem of the Columbia River and its tributaries pursuant to the Pacific Northwest Electric Power and Planning and Conservation Act of 1980 (the Northwest Power Act) (16 U.S.C. 839 et seq.).

The Elmira property consists of upland forested hills bisected by Sand Creek and its riparian corridor. KTOI would incorporate the property into its portfolio of mitigation areas in northwestern Idaho. Management of these properties focuses on improving conditions for resident ESA-listed grizzly bear (*Ursus arctos horribilis*) and bull trout (*Salvelinus confluentus*). KTOI would develop a land management plan to guide the protection and enhancement of habitat and other resources on the property. The land management plan would be drafted within 18 months of closing. The management plan would be reviewed by BPA for consistency with the conservation easement and the purpose of the acquisition. If BPA proposes to fund any additional activities on the property, further environmental review may be conducted.

<u>Findings:</u> In accordance with Section 1021.102 of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, Jul. 9, 1996; 61 FR 64608, Dec. 6, 1996; 76 FR 63764, Nov. 14, 2011; 89 FR 34074, April 30, 2024; 90 FR 29676, July 3, 2025 [Interim Final Rule]) and *DOE National Environmental Policy Act (NEPA), Implementing Procedures* (dated June 30, 2025), BPA has determined the following:

1) The proposed action fits within a class of actions listed in Appendix B of 10 CFR 1021;

- 2) The proposal has not been segmented to meet the definition of a categorical exclusion; and
- 3) There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal (see attached Environmental Evaluation).

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review. ¹

¹ BPA is aware that the Council on Environmental Quality (CEQ), on February 25, 2025, issued an interim final rule to remove its NEPA implementing regulations at 40 C.F.R. Parts 1500–1508. Proposed Action: Elmira Property Acquisition (Update to CX published 3/12/2025)

Project Site Description

The Elmira property is a roughly 260-acre parcel of land located in Bonner County, Idaho. The property consists of rolling hillsides dominated by upland forests of Douglas fir (*Pseudotsuga menziesii*) and ponderosa pine (*Psiloscops flammeolus*). Sand Creek, an important spawning and rearing stream for local bull trout, bisects the property. Sand Creek is ESA-listed critical habitat for bull trout. Additionally, the property supports extensive foraging and winter denning habitat for local grizzly bear and black bear (*Ursus americanus*), as well as grazing for a variety of ungulate species. The property is bordered to the north and northwest by state-owned lands, to the south and east by federally owned lands, and sits within the Grouse Mountain Grizzly Bear Management Unit.
