Thank you for your interest in the Bonneville Power Administration (BPA). We have received your request for records under the Freedom of Information Act (5 U.S.C. § 552). Your request was received on August 10, 2019, and has been assigned Department of Energy (DOE) control number BPA-2019-01297-F. Please use this number in any correspondence with the agency about your request.

## Request

On August 10, 2019, you acknowledged receipt of the responsive records for FOIA request BPA-2019-00620-F. You indicated, via email:

On August 12, 2019, BPA's FOIA Public Liaison replied via email and explained that the FOIA Office would inquire with the agency's appropriate contracting officer, if (1) BPA possessed records such as contractors' cut sheets and inspections, and if (2) those types of records are contractually required to be created and maintained by contractors—with the intent that BPA be able to acquire them. You replied via email:

"As to the second point, there may be a misunderstanding. According to BPA contracts I have examined, BPA creates cut sheets describing in detail the work that is only broadly described in the master contract. Then the cut sheets are given to the contractors, not the

other way around. I believe the contractors may provide some account at billing time of the work performed."

BPA's FOIA Public Liaison contacted the vegetation manager and they explained they had collected cut sheets and inspection records, which are part of the records set responsive to your existing FOIA request BPA-2019-00643-F—which has an estimated response date of October 2, 2019.

On August 23, 2019, BPA's vegetation manager indicated that he found additional inspection reports related to your request BPA-2019-00620-F. Agency personnel did not initially gather those inspection reports because your original request language called for, "all records pertaining to (b) (6) ." The newly identified records were not recorded with the aforementioned street address, but rather with the names of the transmission lines on which vegetation management activities were performed.

The FOIA Office considered your August 10, 2019, email a proper FOIA request and, with your approval, amended it as follows:

## Acknowledgement

BPA has reviewed your request and has determined that it fulfills all of the criteria of a proper request under the FOIA and DOE FOIA regulations at Title 10, Code of Federal Regulations, Part 1004.

#### Response

BPA's Natural Resource Specialist conducted searches of physical and electronic records at the Alvey District's Vegetation Management & Forestry Office. The agency located 64 pages of records responsive to your request. BPA is herein releasing all pages, with 28 pages containing redactions applied under 5 U.S.C. § 552(b)(6) (Exemption 6).

#### **Exemptions**

The FOIA generally requires the release of all responsive government records upon request. However, the FOIA permits withholding certain limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)).

#### Exemption 6

Exemption 6 protects information in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy" (5 U.S.C. § 552(b)(6)), and if there is no public interest that outweighs the privacy interest. BPA asserts Exemption 6 to withhold a limited amount of information to protect

personal information such as landowners' names, schedules, property descriptions, and communications with BPA. BPA can find no public interest in this information, as it does not shed light on the mission or working of BPA, as an agency.

### Fees

There are no fees associated with the response to your request.

#### Certification

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the information release described above. Your FOIA request BPA-2019-00619-F is now closed with all available agency records and information provided.

#### Appeal

The adequacy of the search may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.


