

- We will continue to monitor the potential for flash flooding near burn scars, which will be a growing concern as the fall rainy season begins within the next 2 weeks





Here is what we know so far:

- Marion Substation has been at risk (as of this morning the fire was around a mile away), but we should know more as the afternoon evolves. (Lifesaving is the number one priority, but as of this morning Marion Substation was the fire crews' number one priority. They are cutting a fire line around the substation.)
- The other structure that was at risk was a VHF Radio site.
- Beachie Creek (started Aug. 18) and Mad Hatter Fire (started 9:23, 9/7) combined to make the Santiam Fire yesterday at 2 p.m. (this is an important point because they just renamed the fires, but a lot of the OEM offices don't know and refer to the other fires.)
- The Santiam-Detroit line tripped offline yesterday, but is operational. Ashe-Marion and Buckley-Marion (specifically back in service).

The transmission business set up an incident management team (IMT) yesterday. They are continuing to stand up, but they will be the internal structure for coordinated information, communications, etc. We should start to get regular updates from the IMT.

I will keep you posted as we learn more. We have crews inspecting where and when we can get in to do so safely.



- The weather pattern continues to transition, mostly as expected
- First fall storm system arrives late this afternoon through Friday
  - Red Flag Warning for SE Oregon and southern ID today for gusty winds and low humidity. Relative humidity in this area has been slow to recover in this area. Much higher humidity expected tomorrow for this area.
  - Elsewhere, humidity levels continue to climb, and will be high for the next several days.
  - Risk of landslides and flash flooding is increasing near burn areas, prompting a Flash Flood Watch for the Oregon Cascades and foothills.
  - Lightning is now likely along and west of the Cascades late this afternoon and tonight, and east of the Cascades on Friday. PGPW will issue a new Transmission Weather Alert for this threat later this morning.
  - Widespread wetting rains expected. Some of it could be heavy with thunderstorms.
- The smoke has cleared out entirely from the coast, and slow improvement is spreading up the Willamette Valley. Significant air quality improvement on track for the entire region on Friday.

# BPA Situation Report State Level Status

### Oregon

- Due to the wildfires and widespread hazardous conditions, people seeking testing may have declined.
- The Oregon State Public Health Laboratory (OSPHL) was closed on Monday and Tuesday, due to indoor air safety issues. They reopened on Wednesday and as needed specimens were re-routed to commercial laboratories. As such OHA does not anticipate a large backlog of tests due to the closure.
- Multnomah County reported that not only have they not met all the requirements for applying for Phase 2, their metrics
  are unreliable because of the wildfires. In addition, county testing sites have been closed due to hazardous air quality.

### Washington

- Case counts in both eastern and western Washington have declined substantially since the start of August. These
  decreases are occurring across all age groups. Hospitalizations and deaths, which generally lag trends in cases are
  also starting to show substantial decreases. Case counts in individual counties have generally followed these same
  trends, especially in areas that were previously hotspots.
- While modeling has shown decreasing case counts in the majority of counties with the notable exception of Whitman county, the data has also shown potential beginnings of rises in Benton, Franklin, and Snohomish counties


#### Idaho








