This communication is a final response to your request for Bonneville Power Administration (BPA) records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). Your request was received on June 22, 2021, and assigned tracking number BPA-2021-00841-F. Please use that tracking number in any correspondence with the agency regarding your request.

#### Request

"I would like to request information on EEO cases. All I would like to know is the number (quantity/year), reason (retaliation, harassment, etc.), department (JNPC, etc.). This information should be in the EEO office. I would also like information on terminated employees. All terminations with the same data requirements above. This information should be in the HR department. None of what I am requesting is PII, as I am only looking for the numbers for statistical purposes."

BPA has reviewed your request and has determined that it fulfills all of the criteria of a proper request under the FOIA and Department of Energy (DOE) regulations at Title 10, Code of Federal Regulations, Part 1004.

### Response

BPA searched for and gathered one page of responsive records from the Employee and Labor Relations office and two pages of responsive records from the Civil Rights and Equal Employment Opportunity office. Those three pages accompany this communication in full, with no redactions applied.

## **Appeal**

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
