Dear Mr. Braden,

This communication is the Bonneville Power Administration's (BPA) final response to your request for agency records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). BPA received your records request on September 5, 2023, and formally acknowledged your request on September 22, 2023.

Request

You seek "...information related to job postings within the purview of BPA. Specifically, I kindly request the following information:

- [1.] Of job postings over the past five years, how many were closed with no selection made?
 - -Of those how many veterans applied for those postings?
 - -Of those how many were CFTEs?
 - -What was the length of the posting?
 - -Was the posting reopened?
 - --If yes, how long after was it re-opened?
 - --How long did it stay opened?
 - --How many people from the first posting also applied on the second posting?
 - -- Was there a selection made on the second posting?
 - ---If yes, did that person apply to the original posting?
 - --- Was the selectee who applied on the first posting a veteran or CFTE?
 - -In the past 5 years how many postings has BPA made which the public was able to apply for?
 - --Were all of the postings open for the entire required time previously negotiated?
 - --If no, how many were not?
 - -In the past 5 years how many postings has BPA made which internal BPA employees were allowed to apply for?

- --Were all of the postings open for the entire required time previously negotiated? --If no, how many were not?
- [2.] If there were job postings which were filled using special hiring authorities, where they were not technically posted on USAJobs, within the same 5-year period, I would like to know the posting number, hiring authority used, status of person hired (CFTE, BFTE, Veteran, Disabled, etc.)."

Response

BPA has searched for and gathered records responsive to your request from the agency's Human Resource Center. The records prior to July 2021 are no longer available due to a change in vendors. Therefore, the response is limited to data from July 2021 to approximately October 18, 2023. The 5 pages of agency records accompany this communication, with the following redactions applied:

• One column, redacted under 5 U.S.C. § 552(b)(6) (Exemption 6), on 3 pages.

Explanation of Exemption

The FOIA generally requires the release of all agency records upon request. However, the FOIA permits or requires withholding certain limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)). Further, section (b) of the FOIA, which contains the FOIA's nine statutory exemptions, also directs agencies to publicly release any reasonably segregable, non-exempt information that is contained in those records.

Exemption 6

Exemption 6 protects Personally Identifiable Information (PII) contained in agency records when no overriding public interest in the information exists. BPA does not find an overriding public interest in a release of the information redacted under Exemption 6 — specifically, "request appointing authority." BPA cannot waive this PII redaction, as the protections afforded by Exemption 6 belong to individuals and not to the agency.

Lastly, as required by 5 U.S.C. § 552(a)(8)(A), information has been withheld only in instances where (1) disclosure is prohibited by statute, or (2) BPA foresees that disclosure would harm an interest protected by the exemption cited for the record. When full disclosure of a record is not possible, the FOIA statute further requires that BPA take reasonable steps to segregate and release nonexempt information. The agency has determined that in certain instances partial disclosure is possible and has accordingly segregated the records into exempt and non-exempt portions.

Certification

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the records search, the redactions applied thereto, and the records release described above.

Appeal

The records release certified above is final. Pursuant to 10 C.F.R. § 1004.8, you may appeal the adequacy of the records search, and the completeness of this final release, within 90 calendar days from the date of this communication. Appeals should be addressed to:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
