This communication concerns your records request sent to the Bonneville Power Administration (BPA) and made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). BPA received your FOIA request on September 12, 2023. BPA formally acknowledged your records request on October 16, 2023. This communication is the agency's response to your FOIA request for records.

## Request

"...a full copy of the E3 WMEG: Western Day Ahead Market Production Cost Impact Study, and any other markets studies that Bonneville Power Administration is using to analyze its potential participation or non-participation in a regional day-ahead market, and to help direct its decision towards a specific market option."

## Response

Knowledgeable agency personnel in BPA's Market Initiatives office, in coordination with personnel in the agency's General Counsel office, have publicly posted agency records responsive to your FOIA request. Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the records search and release described above. Your FOIA request BPA-2023-01602-F is now closed, with the responsive agency records and information provided.

#### Appeal

Note that the records release certified above is final. Pursuant to 10 C.F.R. § 1004.8, you may appeal the adequacy of the records search, and the completeness of this final records release, within 90 calendar days from the date of this communication. Appeals should be addressed to:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. You may also submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
