A. View CCO Module

1. Refer to the <u>Conditional Firm Service (CFS) Business Practice</u> for full details regarding CFS conditions and the use of the OASIS CCO Module to manage CFS.

Note: Once the CCO Module is attached to a TSR and the TSR is CONFIRMED on OASIS, the OASIS system identifies it as a CCO Reservation for functionality purposes and limitations through the duration of the CCO Reservation.

- a. Option: HOURS/CONDITIONS
 - i. Max. Hrs: Maximum Hours to be curtailed.
 - ii. Accum. Hrs: Actual Hours curtailed.
 - 1. For a Short-Term Firm (STF) CCO Reservation, once the total Accum. Hours reaches the Max. Hrs, the remaining duration is Firm and conditions will no longer apply.
 - 2. For a Long-Term Firm (LTF) CCO Reservation, once the total Accum. Hours reach the Max. Hrs for the year, the remainder of the year is Firm and conditions will not apply until the next year.

- a. CONDITIONAL_HOURS/EVENT Granted MW is >0 = 6-CF (CFS) for the duration.
- b. CONDITIONAL_HOURS/EVENT Granted MW is 0 = Blank (Firm/7-F) for the duration.

C. OASIS Priority Transition from CFS to Firm

For both System Conditions and Number of Hours, the OASIS functionality automatically changes from CFS/6-CF to Firm/7-F for the duration that Short-Term ATC becomes available on *all* the Managed path(s) for a CCO Reservation.

- Number of Hours: The capacity will remain as Firm even if a curtailment is invoked for a Managed path(s) within the firm duration window.
- System Conditions: The capacity will remain as Firm even if System Conditions are invoked for a Managed path(s) within the firm duration window.

D. CCO Reservation Schedules (e-Tag)

Number of Hours and System Conditions Schedules are 7-F.

- Number of Hours: CCO continuously attempts to allocate STF in the Monthly/Weekly/Daily/Hourly horizons for the CCO Reservation to remove the conditions:
 - If STF is available, CCO leaves priority as 7-F.
 - If STF is not available, CCO changes priority to 6-CF through an e-Tag adjustment.
- System Conditions: CCO continuously attempts to allocate STF in the Monthly/Weekly/Daily/Hourly horizons for the CCO Reservation to remove the conditions:
 - o If STF is available, CCO leaves the priority as 7-F.
 - If STF is not available, CCO leaves the priority as 7-F with no change to the e-Tag.

E. CCO Reservation Limitations

A CCO Reservation is subject to the following limitations per the NAESB standards, even when permanently changed from CFS/6-CF to Firm/7-F for the remaining duration of a CCO Reservation:

- Cannot be used for Consolidation, see the <u>Consolidation of Transmission Service</u> <u>Business Practice</u> for full details.
- Cannot used in an aggregated Resale, see the <u>Resale of Transmission Service</u> <u>Business Practice</u> for full details.
