Pursuant to the notice appearing in the Federal Register on November 8, 2012, regarding the Bonneville Power Administration's ("BPA") Fiscal Year 2014-15 Proposed Power and Transmission Rate Adjustments; Public Hearing and Opportunities for Public Review and Comment, 77 Fed. Reg. 66966, and Section 1010.4 of BPA's Rules of Procedure Governing Rate Hearings, 51 Fed. Reg. 7611 (1986), Calpine Corporation ("Calpine") respectively petitions for intervention as a party in Docket No. BP-14.

In support of this request, Calpine states as follows:

**I. PETITION TO INTERVENE**

Calpine operates the Hermiston Power Plant, a dispatchable thermal generating facility located in Hermiston, Oregon, and is a BPA transmission customer, paying for more than 500 MW of transmission and associated ancillary services at rates that are the subject of this proceeding. Calpine's interest in this proceeding relates mainly to the Dispatchable Energy Resource Balancing Service (DERBS) charge, although it reserves the right to address other matters within the scope of this proceeding. Calpine's interest cannot be adequately represented by any other party.
