10 Pursuant to the Notice of FY 2014-2015 Proposed Power Rate Adjustment issued by  
11 the Bonneville Power Administration, 77 Fed. Reg. 66966, (November 8, 2012), and § 1010.4  
12 of the Rules of Procedure Governing Bonneville Power Administration Rate Hearings, 51  
13 Fed. Reg. 7611 (1986), Idaho Power Company hereby files this Petition to Intervene as a  
14 party in these proceedings.

16 Idaho Power Company is a corporation with its principal office in Boise, Idaho. Idaho  
17 Power Company is an investor-owned utility engaged in among other things, the business of  
18 generating, transmitting, and distributing electric power to customers in the region. Idaho  
19 Power Company is an entity that can contract directly with BPA for the purchase of electric  
20 power and transmission services. The rates that it pays for electric power and transmission  
21 services may be affected by this proceeding. Idaho Power Company's interests will not be  
22 represented adequately by any other party. Accordingly, Idaho Power Company has an  
23 interest in these proceedings, and respectfully requests that it be allowed to intervene as a


16 **WHEREFORE**, for the foregoing reasons, Idaho Power Company respectfully
