

1 NorthWestern is an entity that can contract directly with BPA for the purchase of power under
2 sections 5(b) or 5(c) of the Northwest Power Act for delivery in the region as defined by section
3 3(14) of the Northwest Power Act. NorthWestern's cost of providing electric service to its retail
4 customers will be directly and materially affected by the outcome of this proceeding.

5 NorthWestern is also a transmission customer of BPA. Accordingly, NorthWestern has an
6 interest in these proceedings, and respectfully requests that it be allowed to intervene as a party.




