**PETITION TO INTERVENE OF SOUTHERN CALIFORNIA EDISON COMPANY**

Pursuant to the notice posted in the Federal Register on November 8, 2012, regarding the Bonneville Power Administration's ("BPA") Fiscal Year 2014-2015 Proposed Power and Transmission Rate Adjustments; Public Hearing and Opportunities for Public Review and Comment, 77 Fed. Reg. 217 (2012), and section 1010.4 of the Rules of Procedure Governing Bonneville Power Administration Rate Hearings, 51 Fed. Reg. 7611 (1986), Southern California Edison Company ("Edison") hereby files this Petition to Intervene as a party in this proceeding.

**I.**

**PETITION TO INTERVENE**

This proceeding concerns proposed changes to BPA's wholesale power and transmission rates, including rates for control area services and certain ancillary services. Edison will be responsible for scheduling and transmitting potentially hundreds of megawatts of electrical power from one or more wind-powered electrical generation facilities that are located within BPA's Balancing Authority during the 2014-2015 rate period. Edison anticipates paying for a significant amount of transmission and other services from BPA during this time as it manages

the electrical output from these wind projects. As a result, Edison has an interest in the outcome of this proceeding that cannot be adequately represented by any other party. Accordingly, Edison respectfully requests that it be allowed to intervene as a party in the above-captioned proceedings.
