7 Interest of Intervenor:

8 M-S-R is a Public Power Agency comprised of the City of Santa Clara, the City of
9 Redding, and Modesto Irrigation District, all municipal utilities in Northern California. The
10 members of M-S-R purchase in excess of 350 MW of wind resources from one or more
11 entities in the Pacific Northwest, all of which are in the BPA balancing authority. M-S-R has
12 been a party to the past several rate cases in order to protect its interests and the interests
13 of other wholesale purchasers. As such, M-S-R has a direct interest in the costs, terms, and
14 conditions associated with wind integration, generation inputs, and ancillary services,
15 among other aspects of BPA rates, and, as such is entitled to intervene as a matter of right.

17 THEREFORE, M-S-R requests the Hearing Officer to grant M-S-R intervention as a
18 full party participant to these proceedings.
