Attestations for Glenrock and Seven Mile Hill


PacifiCorp d.b.a Pacific Power hereby submits in electronic format Attestations signed by Rob Lasich, President of PacifiCorp Energy, for the Glenrock and Seven Mile Hill wind resources. These Attestations are submitted in compliance with the Commission's approval of Advice No. 08-021/UE 200. The signed originals are being sent via overnight delivery.

As indicated in the Attestation for Seven Mile Hill, less than 100 percent of the project turbines, as of 10 a.m. this morning, were producing power and connected to the transmission facilities. There is a probability that 100 percent of the project turbines will be producing power and connected to the transmission facilities by the end of the day. However, due to the fact that the Commission approved tariffs included 100 percent of the costs of the facilities and that the Company is required to file by noon today, the Company is also making a compliance tariff filing to remove Seven Mile Hill from the rates in Schedule 202, Renewable Adjustment Clause, to be effective January 1, 2009. Once the Company has completed a final assessment of the facilities that are in commercial operation as of midnight December 31, 2008, the Company will work with Commission Staff and file with the Commission an advice filing to reflect Seven Mile Hill in rates.

Concurrent with these filings and as anticipated in the Commission Staff recommendation for Advice 08-021/UE 200, the Company is also filing a request for deferred accounting to recover (1) the revenue requirement for the period between when the Seven Mile Hill facilities are in service and when the resource is reflected in rates and (2) the dispatch benefits for Seven Mile Hill reflected in the Transition Adjustment Mechanism for the period between January 1, 2009 and when the resource is placed into service, if the resource is placed into service after December 31, 2008.
