To: People Interested in the South Fork Flathead Watershed Westslope Cutthroat Trout Conservation Program

The Bonneville Power Administration (BPA) has completed a final environmental impact statement (FEIS) for the proposed South Fork Flathead Watershed Westslope Cutthroat Trout Conservation Program. The purpose of this conservation program proposed by Montana Fish Wildlife and Parks is to preserve the genetic purity of westslope cutthroat trout populations in the South Fork of the Flathead River drainage. This program is part of the effort to mitigate for impacts to fisheries resulting from the construction and operation of Hungry Horse Dam.

The FEIS was prepared as an "abbreviated" FEIS pursuant to the Council on Environmental Quality's National Environmental Policy Act regulations because there have been no substantial changes to the proposed action, alternatives, or environmental analysis presented in the Draft EIS (DEIS), dated June 2004. The abbreviated FEIS includes the following:

- any changes made to the DEIS (see the Summary),
- comments received on the DEIS (see Chapter 1), and
- agency responses to these comments (see Table 1-2 in Chapter 1).

The FEIS should be used as a companion document to the DEIS, which contains the full text of the affected environment, environmental analyses, and appendices.

If you requested a copy of the FEIS, we have enclosed either a paper copy or a compact disk (CD). The CD contains the complete DEIS and FEIS in the following files:

Next Steps

BPA's Administrator will make a decision about this project in August or September 2005 and document it in a record of decision (ROD). The ROD will state whether BPA will fund this project and, if so, which alternative will be implemented. The U.S. Forest Service will also issue a ROD because the proposed activities require a Forest Service decision. Additionally MFWP will issue a ROD as part of their compliance with the Montana Environmental Policy Act. Each agency will make their ROD available to the public. If decisions are made to proceed with the project, the project would be implemented in the fall of 2006.
