This is an interim response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. 552. You asked for a copy of records pertaining to your late father, Raymond Nelson, during his employment at Hanford from 1952 through 1966 and also the Memorandum of Understanding between the DOE and Bonneville Power Administration (BPA) for mechanical repair services at the Hanford Facility in Washington from 1954 through 1966.

In a phone conversation with Ms. Diana Ngo on March 22, 2013, you specified that you are requesting his medical, radiological exposure, and personnel records, and also agreed to pay up to \$50.00 for fees associated with the processing of your request.

Any documents that may exist at the DOE that are responsive to the request is under the jurisdiction of the Richland Operations Office (ROO) and the BPA. For this reason, I have sent the request to the FOIA Officers at those locations, to conduct a search of their files.
