The statute requires that requests be acted on “promptly,” and “every effort” be made to respond within 20 working days. However, BPA has determined that your request for information is a “complex” request. A complex request is defined in the FOIA as “unusual circumstances” exist. Unusual circumstances are defined as searching inactive records; where a “voluminous” amount of data is involved; where information about other individuals has to be redacted; or where BPA has to consult with another agency which has a substantial interest in the response.

A partial release was forwarded to you on January 27, 2014.

The statute requires that requests be acted on “promptly,” and “every effort” be made to respond within 20 working days. However, an extension is authorized for complex requests. BPA has determined that your request for information qualifies as a “complex” request. A complex request is defined in the FOIA as “unusual circumstances” exist. Unusual circumstances are defined as searching inactive records; where a “voluminous” amount of data is involved; where information about other individuals has to be redacted; or where BPA has to consult with another entity which has a substantial interest in the response. Your complex request involves records that will require redactions and a legal review under Exemption 4 by external entities and our FOIA attorney.

Additionally, “exceptional circumstances” exist due to an unexpected and unusual spike in the volume of requests. We are processing complex requests in a “first in, first out” basis and will keep you apprised of our progress. Our current estimated goal date for completing your request is June 30, 2014.

Under the FOIA, you have the opportunity to limit the scope of your requests, or arrange with BPA an alternative timeframe for processing the requests or modified requests. Please contact our office to make these arrangements.
