RE: Freedom of Information Act requests

Dear Mr. Healy:

Thank you for your requests for records that you made to the Bonneville Power Administration (BPA), under the Freedom of Information Act (FOIA), 5 U.S.C. 552. Your requests were received in this office on Tuesday, December 24, 2013. We have assigned tracking numbers to each; please use these numbers in any correspondence with BPA about your requests.

We have reviewed your requests and have determined that they address all of the criteria of a proper request under the FOIA, Department of Energy, and BPA regulation that implements the FOIA at Title 10, Code of Federal Regulations, Part 1004.

The statute requires that requests be acted on "promptly," and "every effort" be made to respond within 20 working days. However, an extension is authorized for complex requests. BPA has determined that your requests for information qualify as "complex" requests. A complex request is defined in the FOIA as "unusual circumstances" exist. Unusual circumstances are defined as searching inactive records; where a "voluminous" amount of data is involved; where information about other individuals has to be redacted; or where BPA has to consult with another entity which has a substantial interest in the response. Your complex request involves records that will require redactions and a legal review under Exemption 4 by external entities and our FOIA attorney.

Additionally, "exceptional circumstances" exist due to an unexpected and unusual spike in the volume of requests. We are processing complex requests in a "first in, first out" basis and will keep you apprised of our progress. Our goal date for completing your requests is September 30, 2014.

Under the FOIA, you have the opportunity to limit the scope of your requests, or arrange with BPA an alternative timeframe for processing the requests or modified requests. We have attempted to contact you several times concerning this matter. Please contact our office if you wish to make these arrangements.

You agreed to pay up to \$100 in fees for each request; however, due to the length of time that it will take to complete your requests, no fees will be incurred.
