In a phone conversation on January 22, 2014, you narrowed your request for Steve Wright's emails (request #BPA-2013-01407-F) from: "all e-mail to and from Steve Wright between January 1, 2010, and present, that mention the Office of Inspector General, (OIG) the U.S. Office of Personnel Management (OPM) or DOE Human Capital, or any inquiries, reviews and investigations into BPA hiring and promotion practices," to "November 2012 to present."

During the same conversation, you requested that we search for Steve Wright emails regarding the recruitment for the Chief Public Affairs Officer position during the same period.
