If only some of the information/materials requested is readily available, please forward said information immediately – then complete request upon receipt of further information/materials.

A compelling need exists to warrant expedited processing of this request, because a large number of our viewers are immediately impacted by the content of these records. These records relate directly to performance of government in matters of safety, health and well-being. These records also pertain to issues involving widespread media reporting in recent months. Delayed processing jeopardizes important, timely dissemination of information to the public.
