This is a final response to your request for Bonneville Power Administration (BPA) records under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. Your request was received in our office on January 21, 2015, with an acknowledgement letter sent to you on January 28, 2015.

You requested:

Please provide the total amount the BPA spent with the Government Printing Office (GPO) from 6/07-5/12 for posters, door hangers and promotional items such as pens, shirts, mugs.

Response:

We conducted a search of the records of the BPA Printing Office. We were able to pull data from a cost database for the information responsive to your request. We are releasing these records in full.

There are no fees associated with this request.

Appeal:

You may still seek administrative appeal pursuant to Department of Energy FOIA regulations at 10 C.F.R. § 1004.8 if you feel the search was not adequate. If you choose to appeal, you must do so in writing within 30 days, and include the following information:

- (1) The nature of your appeal - denial of records, partial denial of records, adequacy of search, or denial of fee waiver;
- (2) Any legal authorities relied upon to support the appeal; and
- (3) A copy of this determination letter.

Clearly mark both your letter and envelope with the words "FOIA Appeal," and direct it to the following address:
