This letter is in response to your Freedom of Information Act (FOIA) request (enclosed) received by the U.S. Army Corps of Engineers, Portland District on January 29, 2015 for up to four power purchase agreements (PPAs) for Bonneville, The Dalles, and John Day Dams from 1/1/1940 to 12/31/1979. We were unable to identify records responsive to your request during our search. However, we have transferred your request to the Bonneville Power Administration (BPA), which may have records responsive to your request.
