Dear Mr. Spalding,

This is a final response to your request for Bonneville Power Administration (BPA) records under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. Your request was received in our office on July 7, 2015, which we acknowledged on July 9, 2015.

You requested:

"I would like a list of the qualified applicants for the following job announcement:
Job Title/Series/Grade: Manager, District Operations & Maintenance, GS-1601-13/14; Job Announcement Number: 8024-10-BPA; Duty Location: The Dalles, OR; Position Information: This is a permanent position with a full-time work schedule. Anticipated number of positions to be filled: 1; Opening Date: 06/10/10 to Closing Date: 06/23/10; Salary range: GS-13 \$81,823 - \$106,369 & GS-14 \$96,960 - \$125,695; and Organization: Transmission Services, Transmission Field Services, The Dalles District – TFD."

Response:

We conducted a search of the paper and electronic records of the Human Capital Management office. We have located 6 pages of material responsive to your request. We are releasing 2 pages in full and 4 pages with redactions under Exemption 6.

The Freedom of Information Act generally requires the release of all government records upon request. However, FOIA permits withholding certain, limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)).

Exemption 6

Exemption 6 protects information in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy" (5 U.S.C. § 552(b)(6)). Exemption 6 requires balancing the public interest in the information against the individual privacy interest at issue. Here, we assert this exemption to

released; the right of privacy belongs to the individual, not to the agency. Therefore, we did not analyze this information under the discretionary release guidelines in Attorney General Holder's March 19, 2009, FOIA Memorandum.

There are no fees associated with this request.

Appeal:

Pursuant to Department of Energy FOIA regulations at 10 C.F.R. § 1004.8, you may administratively appeal this response in writing within 30 calendar days. If you choose to appeal, please include the following:
